
APPRECIATION AWARD RECIPIENT BILL MANCINI



As President of the CT Chapter of the National Spinal Cord Injury Association (NSCIA) it is a great pleasure for me to attend the Gala and be able to recognize the past year's supporters. Over the past 31 years we have helped many people in Connecticut who have had spinal cord injuries.

The Gala gives us an opportunity to reflect on the past year's events and to discuss the events for the coming year. It gives us a forum to reach out to the attendees and thank them personally for their support as well as to make them aware of events they may want to have a greater involvement with during the upcoming year.

We are updating the CT Resource Directory that we provide the newly injured who receive rehabilitation at any of the following hospitals: Gaylord Hospital, Hospital for Special Care, Mt Sinai Hospital. The Resource Directory is also available online and can be requested through our website at www.sciact.org.

One of the greatest services we provide is Peer Assistance. We coordinate with the hospitals to meet with patients who have had a spinal cord injury. The discussions held range from transportation, sports and activities, our chapter's events, to sex and everyday living in the community. All of the topics have been found to be of great concern for the newly injured.

We also provide a free in-service to Connecticut schools called Stop Trauma. This is facilitated by a Physical Therapist and an SCI survivor. This program which uses the model of "Think First", a countrywide model, promotes the education needed to sustain a healthy and productive lifestyle pertaining to the prevention of spinal cord injury.

A great partnership we formed this past year was with the Christopher and Dana Reeve Foundation. Through this partnership we are extending our support to individuals with spinal cord injury through Peer Mentoring. Peer mentoring is provided by a person who will be able to relate and discuss daily living activities, support groups, and assist, when possible, with obtaining employment, the range of topics is determined by the participants. In many cases, Peer Mentors end up being life time friends to the individuals they have helped.
